HIGHLIGHTS

February 2017 experienced a generally strong performance in major indicators. New jobs were added, decreasing the unemployment rate compared to last year. February 2017 saw a decrease in commercial construction, but a rise in single-family home construction over February 2016. More travelers flew from Omaha, reversing the slight decrease of January.

2017 Barometer

How does Greater Omaha compare to other thriving metros across the U.S.? Each year the Barometer measures Greater Omaha's momentum in eight key economic and performance-related areas to take a hard look at our region's strengths and opportunities. In 2017, Greater Omaha held steady on its overall rank of 5 out of 10, meaning we have maintained forward momentum on pace with 9 other thriving comparison metros. Our strengths include successful entrepreneurs, low business costs, basic human capital and a wide variety of leisure and entertainment options. We have further room for improvement in innovation categories, such as patent activity and knowledge-based workers.




HOME SALES (OMAHA MSA)
